NOTICE OF RELEASE OF INFORMATION PROSPECTUS

"ADMIE (IPTO) HOLDING S.A." (or «Company») announces that the Information Prospectus was made available to investors, the content of which was approved by the Board of Directors of the Hellenic Capital Market Commission on 12.06.2017, for the admission to trading of a total of 232,000,000 common registered shares of the Company (hereafter the "Listing") on the Main Market of the Athens Stock Exchange ("ATHEX"). The announcement is issued in accordance with Regulation No. 809/2004 of the European Parliament and of the Council, as well as the Law 3401/2005.

The Stock Markets Steering Committee of the ATHEX, during the session held on 12.06.2017, accepted the application of "ADMIE (IPTO) HOLDING S.A." for the listing of its shares on the Main Market of ATHEX, upon the condition of completion of the corporate action of "PUBLIC POWER CORPORATION S.A." (share capital decrease of PPC and capital return through distribution in kind of the shares of the newly-formed company ADMIE (IPTO) HOLDING S.A. to PPC's shareholders, with a percentage holding equal to their participation in the share capital of PPC).
