The decision for the payment of dividend, as well as the above relevant dates, are subject to approval of the Annual General Meeting of Shareholders.

It is noted that, for FY2023, ADMIE Holding S.A distributed a gross interim dividend of EUR 13.5 million, or EUR 0.058 per share, which was the maximum allowable amount on the dividend received from the taxable profits of the year 2022 by IPTO S.A., within the Fiscal Year 2023, in accordance with the provisions of Law 4548/2018. This amount constitutes the final payment of the dividend for the Fiscal Year 2023. The Board of Directors will propose the distribution of the maximum allowable amount received as dividend by IPTO S.A. within 2024, as interim dividend.

The Company reserves the right to alter the above dates, after timely informing investors of the amendment hereof, as defined in the Athens Stock Exchange Regulation.
